Transport infrastructure, Infrastructure and Highways, Trade and Commerce – PERMANENT ban on Electric Vehicles, FORTHWITH.

I AM, HRM Queen Romana Didulo, Commander-in-Chief, President, National Indigenous Chief and Queen of the Kingdom of Canada, hereby issue this Royal Decree effective immediately dated today September 23, 2024 as follows, under “Natural Law.”

#### Section 1 – Electric Vehicles Manufacturing

Forthwith, the manufacturing of “ELECTRIC VEHICLES” is prohibited and permanently banned in The Kingdom of Canada.

#### Section 2 - Electric Vehicles Exporting

Forthwith, the exporting of “ELECTRIC VEHICLES” is prohibited and permanently banned in The Kingdom of Canada.

#### Section 3 - Electric Vehicles Importing

Forthwith, the importing of “ELECTRIC VEHICLE[S]” is prohibited and permanently banned in The Kingdom of Canada.

Section 4 – Forthwith, implement and execute closures/shutdowns of all manufacturing and processing plants specific to manufacturing, exporting and or importing of Electric Vehicles and all of its components in The Kingdom of Canada.

Section 5 – Forthwith, cancel, revoke, nullify, void and disband any and all programs, ministries, bureaus committees, commissions, initiatives pertaining to electric vehicles in The Kingdom of Canada.

Section 6 – Forthwith, cancel, revoke, nullify, void, disband and prohibit, and DE-FUND any and all programs, initiatives, advertisements, etc pertaining to Electric Vehicles in The Kingdom of Canada

#### Section 7 – Electric Vehicles on Kingdom of Canada’s Highways and Roads.

Forthwith, due to safety [lithium battery], safety, and security concerns pertaining to Electric Vehicles high propensity to explode and catch on fire....a complete, absolute, and full ban on electric vehicles [of all kinds] inclusive e-bikes/e-scooters from all Roads, Highways, public places, will take full effect on September 22, 2025 in The Kingdom of Canada.





This will provide one full year for Owners of Electric Vehicles to find other means of transport, seek compensation for defective products from manufacturers and sellers of electric vehicles, e-bikes/e-scooters, etc.

#### Section 8 - General contractors Nationality

Forthwith, ensure all “general contractors” [previously known as employees] at Ministry of Transport Canada are Canadian Nationals only across The Kingdom of Canada.

#### Section 9- Automobile Business Nationality

Forthwith, ensure all Automobile Business Owners are Canadian Nationals only.

#### Section 10 - Automobile Businesses ownership and control

Forthwith, ensure all Automobile Businesses ownership and control are 100% Canadian Nationals only.

#### Section 11 - Contracting / Sub-contracting

Forthwith, contracting / sub-contracting to non Canadian Nationals is strictly prohibited and unlawful.

#### Section 12 - Ministries/Bureaus and or Departments affected by this Royal Decree

Forthwith, all Ministries/Bureaus and or Departments affected by this Royal Decree are hereby instructed to work cohesively and ensure companies are fully in compliance with all requirements herein.

#### Section 13 - Violators of this Royal Decree

Violators of this Royal Decree shall be charged with economic sabotage, treason, enslavement, slavery, financial fraud, corruption, embezzlement, crimes against homo sapiens / crimes against humanity.

#### Section 14 - Daily financial penalty

Daily financial penalty of “one billion dollars” backed by gold and silver for every violation / infraction.”

This Royal Decree is effective immediately.

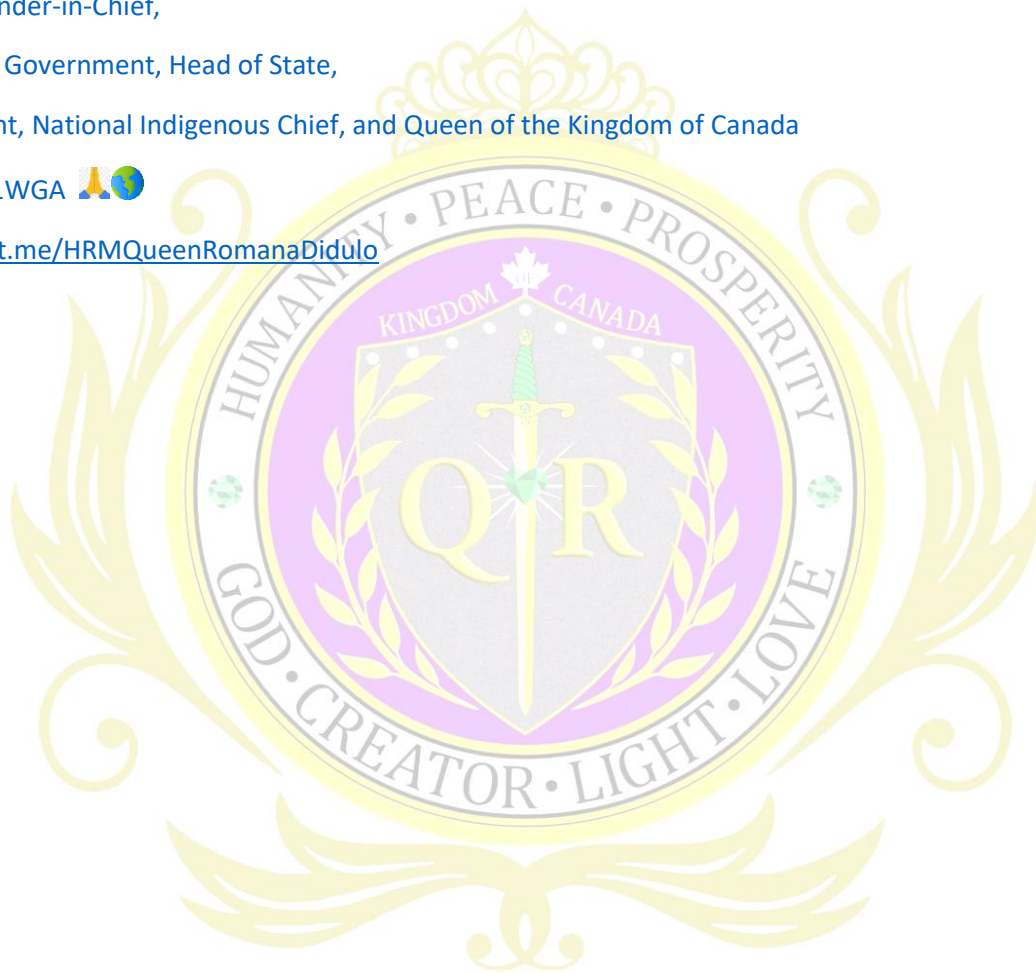

1] FORTHWITH; Search, Freeze and Seize all Bank Accounts and all Realty Assets, Gold and Silver holdings, Investments, Shares in other Companies, stocks, and bonds, insurance, etc, etc, of foreign and domestic domiciled Corporations, Professional Associations, Trade Associations, Grain Elevator Associations, UNIONS, UNION Chapter[s], Foundations private or public, Charitable Organizations, etc who have caused financial damage and disruption to The Kingdom of Canada's supply chain, due in part or whole of their membership or executive or management decisions and actions.

2] FORTHWITH; Arrest and charge all Chairman of the Board, Executive Board Members, Management, and Members of Foreign and Domestic domiciled Corporations, Professional Associations, Trade Associations, Foundations private or public, Grain Elevator Associations, UNIONS, UNION Chapter[s], Charitable Organizations, etc who have caused financial damage and disruption to The Kingdom of Canada's SUPPLY CHAIN, FOOD SECURITY, AND ECONOMIC STABILITY, ECONOMIC SAFETY, ECONOMIC SECURITY AND ECONOMIC SOVEREIGNTY due in part or whole of their membership or executive or management decisions and actions. with the following:

- a] domestic terrorism,
- b] international terrorism,
- c] blackmail and extortion,
- d] artificial creation of famine,
- e] economic sabotage,



f] Crimes against Canadian Nationals [every man, lady, baby boy, and baby girl]/ CRIMES AGAINST Humanity

3] FORTHWITH; arrest and charge with domestic terrorism, treason, money laundering, fraud, creation of artificial famine, embezzlement, crimes against homo sapiens anyone who has/is misused, stolen, and laundered, the monies allocated previously for this industry.

4] FORTHWITH; arrest and charge with FORCED LABOUR / Trafficking / Human Trafficking, Enslavement, under the disguise of employment association/ membership where the management of the said association /union decides where the Man/Lady is to take up employment, when to work, and how much his/her salary or hourly wage is. This is in reality slave ownership and slave management.

5] FORTHWITH; financial penalty for economic disruption, supply chain disruption etc, shall be levied as follows:

a) one hundred times [100x] the total amount calculated on the financial damage caused to The Kingdom of Canada's economy for every industry. For example; if an industry farming loses five hundred million daily - the financial penalty shall be one hundred [100x] daily for that specific industry.

6] FORTHWITH; an hourly INTEREST shall be levied on the concerned entity calculated at the rate of 1000% of the total daily penalty.

7] FORTHWITH; the financial penalties [see number 5 above] are payable "upon demand" by The Kingdom of Canada. In this case, the financial compensation is demanded FORTHWITH.

8] Under Natural Law, the rights and freedoms of a special interest group[s] to seek better wages and better working conditions do not supersede the economic stability, economic safety, economic security and economic sovereignty of The Kingdom of Canada.

This Royal Decree is effective immediately.

Further, I AM Her Royal Majesty Queen Romana Didulo, request immediate Air space clearance on Humanitarian grounds to extract Canadian Nationals from the Country of Lebanon.

Further, I AM Her Royal Majesty Queen Romana Didulo, request all those whom it may concern to allow to pass freely, without delay or hindrance and to afford all Canadian Nationals assistance and protection as maybe necessary as they exit of Lebanon and may seek immediate shelter in,

The Kingdom of Saudi Arabia,

Turkey,

Kingdom of Qatar,

Kingdom of Kuwait,

Kingdom of Jordan,

United Arab Emirates,

Iraq,

Kingdom of Bahrain,

Syria, and or any other GCC Nations.

- 1] Forthwith, deploy 200 military personnel for NON COMBAT [search, rescue and extraction] MISSION to extract, all Canadian Nationals in Lebanon requesting immediate exit and extraction from Lebanon.
- 2] Forthwith, deploy Military Aircraft [2x] CC-177 Globemaster III, a strategic airlifter that transports troops, cargo, and oversized combat equipment.
- 3] Forthwith, deploy Military Aircraft [2x] CC-130J Hercules, a tactical airlifter used for a wide range of missions, including troop transport, tactical airlift, and aircrew training. It can land and airdrop heavy loads of equipment, supplies, and personnel into hostile environments.
- 4] Order of priority:
  - a] Children and Youth [under the age of 24]
  - b] Pregnant Ladies and those with acute medical care requirement/needs
  - c] Seniors [Ancestors]
  - d] Men and Ladies
- 5] Allocate twenty five million dollars for this emergency situation.
- 6] This extraction of all Canadian Nationals in Lebanon must be carried forthwith and completed on or before 72 hours from this this hour, 1300 hrs September 26, 2024
- 7] Emergency Shelters must be prepared for all Canadian Nationals arriving from Lebanon, if they have zero family members to go home to in The Kingdom of Canada.
- 8] The emergency Shelter must have food, water, clothing, and a personal hygiene hospital [temporary location].
- 9] Forthwith, all Ministries/Bureaus and or Departments affected by this Royal Decree are hereby instructed to work cohesively and ensure companies are fully in compliance with all requirements herein.

b] Forthwith, the use of propaganda to promote pharmaceutical synthetic untested and unproven [zero traceable evidence demonstrating its efficacy and safety for a minimum of thirty [30] years for children and adults and animals injections/vaccines of any kind for whatsoever purpose is unlawful, prohibited, and permanently banned in the Kingdom of Canada

Special Note 2) If needed, spend \$50,000.00 dollars [\$50,000.00] building a National Directory with all programs and services for the unhoused across The Kingdom of Canada, as described below.

Special Note 3) This National directly of services and programs for the unhoused must be published online [digitally] on or before March 1, 2025





Special Note 4) This directly of services and programs for the unhoused must be published manually [notebook with coil binding] on or before March 1, 2025

Seamless delivery of programs and services [database and service]. The Ministry of Housing must create and develop both a database and directory of all short term and long term assistance, services and programs available to all unhoused Canadian Nationals

This directory of all assistance, programs and services must be sorted as follows:

- 1) By Province / Territory
- 2) By City/ Municipality/Town/Village
- 3) By Age Group
- 4) By Gender [feminine and masculine]
- 5) Families with Children under the age of 24 years old.

Further, this database must be shared with following Ministries:

- i] Ministry of Children and Youth
- ii] Ministry of Ancestors/Seniors
- iii] Ministry of Family

4b] Assistance, services, and program coordination and prevention of duplication

Special Note:

The above database is being made accessible to the relevant Ministries to ensure there is ZERO duplication in assistance, services and programs provided to each and every unhoused Canadian Nationals.

5] Emergency Assistance



Forthwith, the following urgent and immediate assistance must be provided to each and every unhoused Canadian National.

5a] Emergency - Emergency Funding for short / long term accommodation Rental Fees [\$2500 to \$3000 monthly per person]

5b] Food Funding for short /long term Grocery Needs [\$300 weekly/ per person = \$1200 monthly]

5c] Transportation Free Adult Bus Pass / Monthly \$150, monthly

5d] Transportation with vehicle -Five Hundred Dollars[ \$500] for Gasoline/monthly

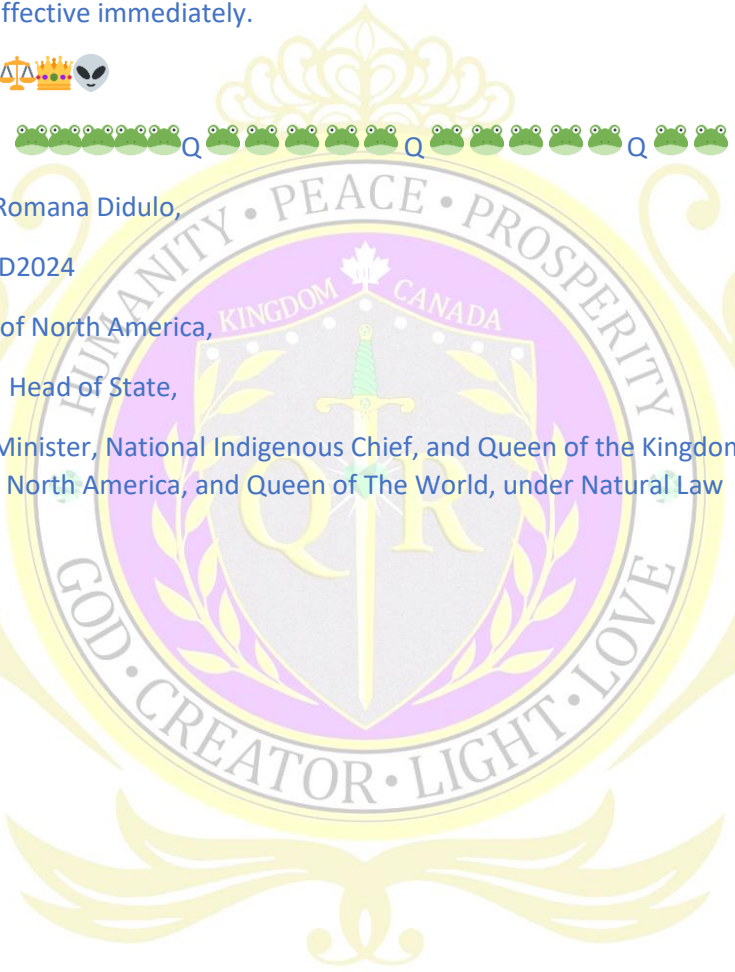

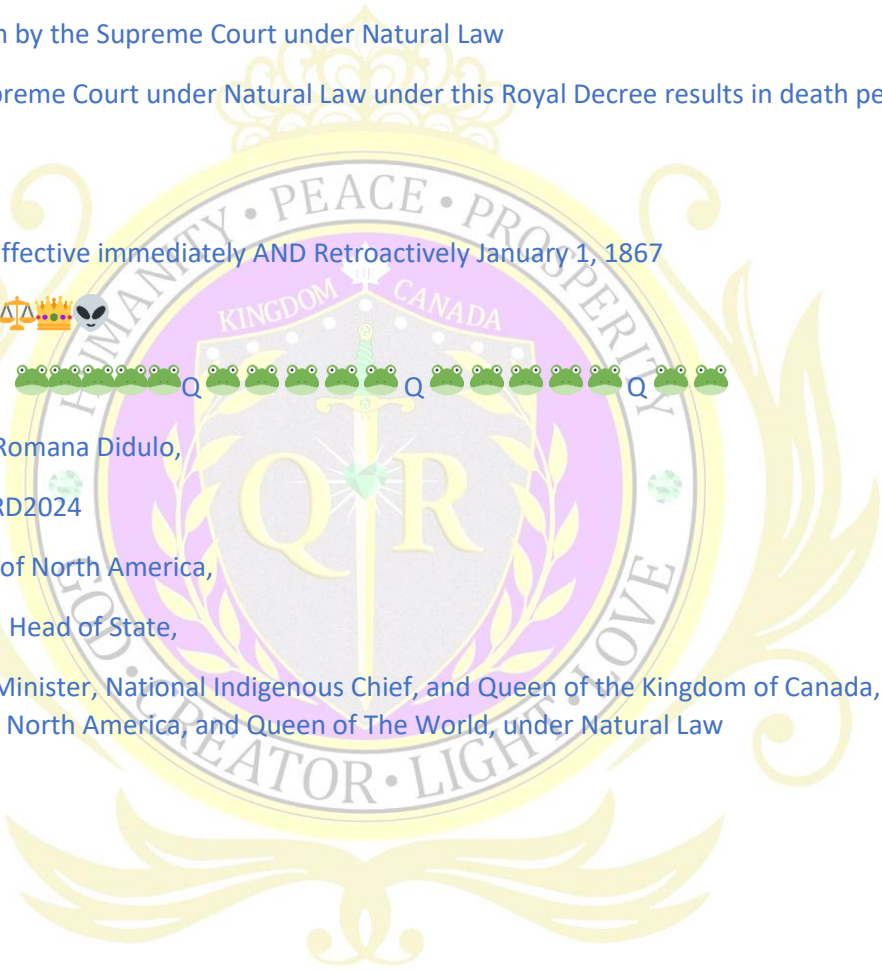

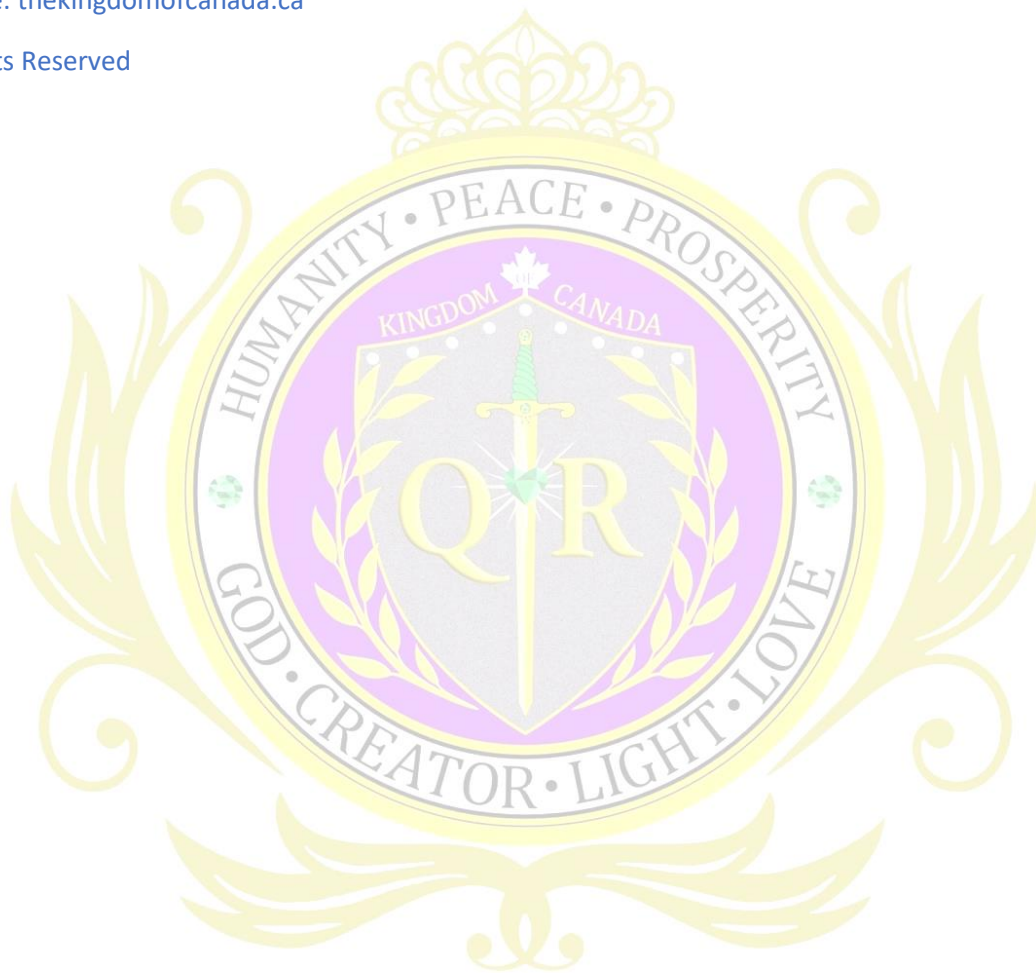

I AM Her Royal Majesty Queen Romana Didulo, Commander-in-Chief, President, 1st Prime Minister, National Indigenous Chief and Queen of the Kingdom of Canada hereby issue this Royal Decree, dated today February 13, 2025 to all Kingdom of Canada and Global Special Allied Forces AND respective Ministries to action FORTHWITH this Royal Decree as specified herein under Natural Law;

#### Section 1]

FORTHWITH, it is illegal, unlawful, criminal, and fraudulent for individuals, business(es) and or organizations foreign and or domestic to appraise and or assess the value of any realty property based upon one, and or any, and or all of the following:

- i) False,
- ii) Incomplete, and
- iii) Inaccurate data by using the following matrix as listed below:



Special note: This list is not exhaustive...

- (a) market speculation = false, incomplete, and inaccurate data
- (b) market manipulation = false, incomplete, and inaccurate data
- (c) previous assessments – using guess work data to produce previous market speculation and manipulation to come up with its false and fraudulent valuation.
- (d) supply and demand data = data originating from speculative numbers
- (e) market averaging = not representative of actual value of the real property. For example, real cost of material used, labor cost, and land cost.
- (f) market projection = false, incomplete, and inaccurate data
- (g) market survey = false, incomplete, and inaccurate data
- (h) previous sales data = false, incomplete, and inaccurate data
- (i) auction data = false, incomplete, and inaccurate data
- (j) mortgage backed securities = false, incomplete, and inaccurate data
- (k) mortgage bonds = false, incomplete, and inaccurate data
- (l) registered covered bonds = false, incomplete, and inaccurate data
- (m) data comparing provinces and territories, cities, town, etc, data = false, incomplete, and inaccurate data
- (n) speculation based on population growth = false, incomplete, and inaccurate data
- (o) based on local industries = false, incomplete, and inaccurate data
- (p) based on market trend = false, incomplete, and inaccurate data (bidding price war set by select few criminal and greedy individuals)
- (q) based on demographics = false, incomplete, and inaccurate data



- (r) based on mortgage rates = false, incomplete, and inaccurate data
- (s) mass appraisal, again based on speculation not real value) = false, incomplete, and inaccurate data
- (t) mortgage insurance = false, incomplete, and inaccurate data
- (u) based on previous old system such as admiralty law, civil law, common law, maritime law, or any forms of laws, etc, etc, that supported taxation, economic enslavement, thievery by the state programs and fraudulent schemes on mass perpetuated on We The People = false, incomplete, and inaccurate data
- (v) any type of insurance schemes used as benchmarks to speculate the value of a real property = false, incomplete, and inaccurate data

- (z) construction data, etc. = false, incomplete, and inaccurate data

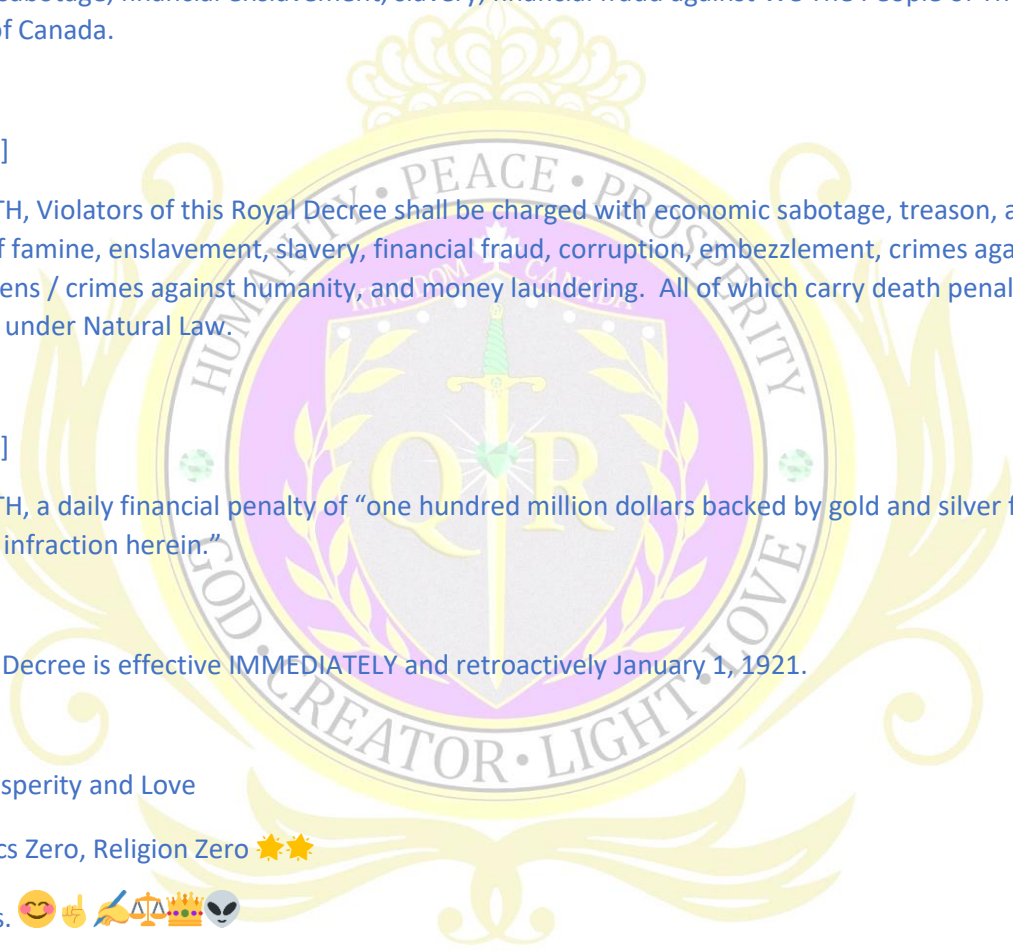
## Section 2]
